Additionally, the project draws on visual anthropology to study visual representations. This means that I observe in exhibitions and the conversations in which roles exiles are perceived. Are exiles framed as victims? Are current exiles displayed but with the images of historic exiles in head? Does the display rely on a specific knowledge of the visitors?

Preliminary findings

All interview partners agreed so far that the topic 'exile' has gained new attention within the last years. In the case of the Philipp Schwartz-initiative, this actually lead to its foundation as an expansion of the pre-existing Alexander Humboldtvon Stiftung. Practically, the different institutions have all chosen to tell history of exile the via biographical examples. This approach is chosen in order to render exile comprehensible.

They are debating, however, how biographical material much should be used compared to socalled 'superordinate' information different which connects biographies and, thus, highlights common themes. They attempt to find a balance between famous exiles whose stories are already known and lesser known exiles. As institutions at least partially depending on public funding, the interview partners have pointed out the necessity to engage with exile alongside their public commission's definition. This poses some limitations when they would want to deal with exiles other outside their denomination.
